Update on Sand Pit acquisition.

Commissioner Chitwood received an e-mail from Ben Southwick regarding eminent domain offer to Teresa Schneider. (Jurisdictional offer of \$220,000.00). Motion by *Marshall*, seconded by *Kinney* to proceed with the eminent domain process. Motion carried.

Discuss outcome of "Turnout for Transportation" meeting.

The meeting was held Thursday night, September 29th, 2016. Commissioner Chitwood and Town of Dayton Chairman Wastlick hosted the meeting. There were also meetings in all counties. Chitwood sent a letter to the Richland Observer summarizing the meeting – basically we need more money for transportation. There were no legislature personnel in attendance.

Approve policy change involving summer work hours.

Commissioner Chitwood request change to summer work hours to be 6:30 a.m. to 4:30 p.m. to make this a straight 10 hour day. The reason for the request is to eliminate paying overtime when employees work through their lunch hour. Richland County is one of four counties that still do ½ hour lunch during the busy construction season. Moved by *Kinney*, seconded by *Marshall* to take to Finance & Personnel the change requested. Motion carried.

Discuss need for local ordinance involving road closures.

The problem is: people drive around/move barricades with road closures. The Sheriff's Department can't do anything without an ordinance. It is a danger to the public and Highway Department worker's. The question was raised, should this be put on Law Enforcement's agenda? Moved by *Sebranek*, seconded by *Marshall* to send to Law Enforcement to be put on their agenda. Motion carried.

Discuss effects from August/September flooding.

There was 424 hours of overtime. We requested lowa County to bring a rubber tired excavator and operator to assist us with flooding repairs. This has been a very trying flooding season. The cost for the third flooding event is approximately \$100,000.00.
