Read and approve the agenda.

Moved by *Marty Brewer*, seconded by *Larry Sebranek* to approve and accept the agenda as read. Motion carried.

Parking Lot - Update

The Highway Department Commissioner stated to the Natatorium Board that the Department has confidence in the new parking lot lasting just as long as the previous lot. There are some imperfections and cosmetic areas due to soft base they had to work with. The Highway Commissioner stated that the work his department has completed was done for far less than any other private sector contractors and that the Highway Department is a not for profit entity. The Highway Department would like to be compensated only for the time and materials that have been used to complete this task. The Natatorium Board took time to express their concern with issues of ponding in the parking lot, as well as the rough surface and the raised edges along the sidewalk areas. This has raised the concern for public safety as well as the concern of the longevity of the new parking lot. The Richland Center City Council stated that these are the same concerns they would like to have addressed. After much discussion the Highway Commissioner proposed looking at the parking lot in the spring of 2019 and addressing any pavement failures at that time. The Commissioner would also like to crack seal the parking lot at no additional cost. Moved by *Marty Brewer*, seconded by *Buford Marshall* to address failures in the parking lot in the spring of 2019 as well as completing crack sealing at no additional cost. Motion carried.

Motion to adjourn the meeting by *Buford Marshall*, seconded by *Steve Williamson*. Motion carried.
